- As the college is due for 3<sup>rd</sup> Cycle of NAAC A&A in the month of December 2019, the monitor committee in its formal meeting held on dated 12<sup>th</sup> October 2018 directed to the Principal to arrange the detailed Orientation Programme for the faculties on the New Methodology of NAAC Assessment & Accreditation, by inviting suitable resource person to enlighten them about the NAAC process of A&A.
- Based on this direction, the Principal arranged the first Orientation Programme for faculty Members about **NEW NAAC MANNUAL** on 5<sup>th</sup> November 2018 by inviting Dr. L.S Sheshgiri, a resource person from Bangalore and subsequently, two workshop, orientation for the faculty was arranged on 7<sup>th</sup> & 8<sup>th</sup> November 2019. In all these three days orientation workshop, Dr.Sheshgiri has explained to all faculties in detailed about how to give the response to the criteria wise SSR (both in QIM & QnM questions) and what are the necessary documents or reports, photo evidences to be uploaded as supportive documents in our responses to get good score in the NAAC Assessment process.
