### **Punishment for Ragging**

- 1) Expelled from the institution
- 2) Banned from the Hostel
- 3) Scholarship can be withdrawn
- 4) Debarred from Examination
- 5) Denied Admission to institution
- 6) Prosecuted for criminal action
- 7) Institution have been asked to file the FIR with local police against them

Due to the above mentioned efforts, no ragging incidents have been occurred during this year.
