As per the revised UGC guidelines issued in circular dated 26.10.2017 in order to prohibit, prevent and eliminate the scourge of ragging from our college campus, we have taken the following measures.

1. Students, Parents, Guardians are made aware of Anti-Ragging Committee of our college. To comply with revised UGC Regulations, at every academic year compulsorily each student and parent are informed to submit online undertaking about Anti Ragging to the website [www.antiragging.in](http://www.antiragging.in) or [www.amanmovement.org](http://www.amanmovement.org).
2. In case of distress, students who owing to ragging have informed about the availability of National Anti Ragging Helpline 1800-180-552.
3. Regular & surprise inspection by our college Anti-Ragging Committee on Hostel Canteen, toilets, other places in the campus in order to prevent/quelling ragging and any uncalled behaviors or incident in the campus.
4. We have installed the CCTV cameras at vital points, such as at entrance in class rooms, library building and other places. In case any culprit found in the involvement of Ragging relating activities have quenched in the bud itself.

5. We have informed to our students regarding what act is there for Ragging and what punishment is there for Ragging. And also displayed the slogans relating Anti-Ragging on the college, Notice Board, in the Library Notice Board and thereby created awareness about the Ragging.

As per the Anti Ragging/UGC-SWRO/2016-17 circular dated 26.10.2017 we informed to students and parents about expanding perview of "Ragging" which says as follows: Any act of Physical or mental abuse targeted to another student on the ground of color, race, religion, caste, ethnicity, gender, sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.
